Pursuant to my rights under the California Public Records Act (Government Code Section 6250 et seq.), I ask to obtain a copy of the following, which I understand to be held by your agency:

All information below is for anyone graduating high school from 2018 - 2022 (through Pupil Records —EC Section 49060 et seq)

- First Name of High School seniors
- Last Name of High School seniors
- Email address of High School seniors
- High School Graduation Date
- First and Last name of parent or guardian
- Parent/guardian Home Address
- Parent/guardian Email Address

I ask for a determination on this request within 10 days of your receipt of it, and an even prompter reply if you can make a determination without having to review the records in question. If you determine that any or all of the information qualifies for an exemption from disclosure, I ask that you note whether, as is normally the case under the Act, the exemption is discretionary, and if so whether it is necessary in this case to exercise your discretion to withhold the information.

If you determine that some but not all of the information is exempt from disclosure and you intend to withhold it, I ask that you redact the exempt portion(s) for the time being and make the rest available as requested. I would prefer the request filled electronically, by replying to this request in pdf. format by attachment.
