- 7.0 PUBLIC COMMENT ON PUBLIC SESSION ITEMS.
 - District goals and vision were requested by Chris DeVries. Mr. Tracy responded that the goals have been published and he will resend a copy.
 - Tom Conwell requested the District/Board send a letter to Leah Eddy thanking her for her service to the Cheer team and district. District concurred.
- 8.0 **COMMUNICATIONS/REPORTS**.
 - 8.1 Board Member Comments/Reports. None.

- 8.2 Diego Martinez, Student Body President, reported on current activities including: STAR testing completed, Baseball team Section Title; softball, track athletes going to sections, and a successful prom.
- 8.3 Ms. Vogelesang reviewed the yearly preschool evaluation for the state. She explained the three areas evaluated, action steps, and parent survey. The survey indicated a need for parent involvement, which will be implemented next year. New games and activities were demonstrated and a few parent comments were shared. She is starting the process to obtain Butte College students as mentors next year.
- 8.4 Maintenance, Operations, and Transportation Report by Marc Eddy. Bus routes for 2012-13 were covered by Mr. Tracy. Next year the district will move to a single bus route due to budget cuts. Changes will be communicated to parents.

Marc Eddy reported on: buses retrofitted by state funds; 100+ extra-curricular trips at about 11,000 miles; new lawn mower on site; summer projects: retrofit of thermostats in gym and two cafeterias for remote access, alarm notifications, and energy efficiency.

- 8.5 Principals and Dean of Students Reports.
 - 1. Mr. Cris Oseguera, Hamilton High Principal, distributed handout and reported on CAHSEE results, STAR test administration, AP tests, upcoming events, and summer school, June 11-29 at EBHS. He congratulated the Baseball team on Section title, Bill Boone on induction into Glenn County Educator's Hall of Fame, Karlene Shipplehoute for being crowned Ms. Glenn County, and Mr. Bentz and Ms. Lohse for an excellent job in their fair activities.
 - Ms. Lohse: One of the best years ever at fair! Kids brought home \$99,947 so far and awards were won in multiple categories.
 - 2. Ms. Maria Diaz, Hamilton Elementary Principal, distributed handout and reported on May and June activities including STAR testing, successful May Festival Dance, field trips, and promotion ceremonies. SEI assessments were explained and reviewed for academic growth by grade.
 - BTSA Presentation by Stephen "Kile" Taylor. His second-year teacher, action research project focused on a bully prevention program recently put into place in HES and how to accommodate students with disabilities.
 - 3. Ms. Maria Reyes, Ella Barkley High Dean of Students, distributed handout and reported on enrollment, senior projects, STAR testing, Career exploration, and six students on track to graduate.

- 3. Communications: Letter from Randy Jones, GCOE Assistant Superintendent of Business Services, which concurs with the positive certification finding approved by the District Governing Board for the 2011-12 Second Interim Review.
- 4. PERS Two Year Retirement Incentive. A county-wide window is required to offer this incentive. Another district has started the process. To open as a benefit to our employees we are scheduling a special board meeting this Friday at 8 a.m. in the high school conference room. The district must demonstrate a cost savings.

To solicit input on BP 6163.4, Student Use of Technology policy update regarding CIPA and Protecting Children in the 21st Century Act Compliance Requirements on the District's computer/website access filtering policies and the education of minors and staff on cyber bullying and appropriate online behavior. - 9.2 <u>Public Hearing</u>: 7:44-7:47 PM. To solicit input on General Waiver Request: Education Code 48660, Grade Span for Hamilton Community Day School in order to serve students from grades K to 12 rather than 7-12. Mr. Tracy reported and there were no comments.
- 9.3 Public Hearing. 7:47- 7:55 PM. Relating to the Use of 2012-13 Tier III State Categorical Funds Education Code §42605 grants districts flexibility in Tier III categorical programs and authorizes districts to use these funds for any educational purpose. Ms. Lyon's explained the Tier III State Categorical funds flexibility. Mr. Bentz sought clarification on SB70 Career Tech, which was provided by Mr. Tracy.
- 9.4 Resolution calling for an election authorizing the issuance of general obligation bonds of the district at an election to be held November 6, 2012. Discussion ensued. Consensus of Board is to give the economy a rest and let the bond rest at this time.
- 9.5 Request for water fountain at Edgewater Park. The drinking fountain would be a donation and maintained by the donor. The donor has provided assurances which will protect District, and District recommends accepting donation contingent up on requirements being met.
